For those of you feeling the good energy in this book, please raise your hand! Powerful, powerful, powerful! My emotions were all over the place with this book. It is a testament to the proficiency of an author when they are able to take their audience through the gamut of emotions. XF brings to light many of the geo and sociopolitical issues that we see across the divide and across the lines of colour globally, but most importantly in our society plaguing the relationships between people of

African and European descent. When you are automatically granted due to one's race an inbuilt institutionalised system of privilege and rewards, it's difficult to understand or even acknowledge when others are not being given the same privilege (because it does not affect you). I most especially enjoyed the debate sparked in Professor Hillman's class. Can I say powerful? Wow...powerful. So many diametrically opposing views and each one so very valid! At one point I would agree to a point of view being expounded upon by one student, and after hearing the other points of view, I was shaking my head in agreement; thinking to myself I never thought of it that way and yet that too is true. On the other hand, I disliked how Ryan was constantly chasing after Dâ™asia, and she never seemed to meet him halfway. It seemed as if one moment she is being portrayed as this strong character and the next moment she is a weak-willed woman afraid of communicating and running at the slightest sign of trouble. We're also left with an inconclusive ending regarding their relationship. Are they or are they not together? Because as it stands this question is never clarified, leaving readers feeling as if the author ran out of steam and rushed the ending.
